Lao PDR		This work program will follow from and builds upon the findings of the health financing system assessment that was conducted and finalized this year in Lao PDR. The focus of the work is technical assistance supporting the government's implementation of the Health Governance and Nutrition Development Project, which recently added financing for strengthening immunization in the context of stronger health systems. The project now includes several disbursement-linked indicators on immunization, including one in which disbursement is tied to the number of villages where integrated outreach (including immunization and other identified essential health and nutrition services) is conducted at least three times during the year (DLI-5), and another indicator in which funding of the project is tied to improved immunization coverage at the district level (for Pentavalent 3, measles and rubella), in the 50 lowest performing districts in the country. These incentives are particularly important for improving coverage and equity because currently, integrated outreach services are provided on an ad hoc basis and with insufficient frequency to make an impact, and they don't always include the full package of services which would contribute to enhanced system-wide ownership of this outreach and contribute to its sustainability. The efforts also aim to improve facility-based services in 'zone 1' areas, located near the health facilities, so that outreach is prioritized for the more remote communities as per government policy. The technical assistance will also support integration of immunization information system with the DHIS2 webenabled platform, and efforts to improve data quality.
