Since the June 2021 Board meeting, three decisions have been circulated to the Board electronically for approval by no-objection consent in line with Section 11 of the Board and Board Committee Operating Procedures.

1) On 19 July 2021, Board members were invited to consider **approval of the appointment of an Alternate Board Member.**

No objections were received prior to the end of 29 July 2021 and the following decision was therefore entered into the record:

In accordance with Section 11.3 of the Board and Board Committee Operating Procedures, on a no-objection basis, the Gavi Alliance Board:

<u>Appointed</u> Gilbert Mokoki of Republic of Congo as Alternate Board Member representing the implementing country constituency in the seat currently held by Jacqueline Lydia Mikolo of Congo, effective immediately and until 31 December 2021.
