Since the June 2024 Board meeting, eight decisions have been circulated electronically for approval by no-objection consent in line with Sections 11 and 12 of the Board and Board Committee Operating Procedures.

1) On 9 July 2024, Board Members were invited to consider **approval of the appointment of an Alternate Board Member.**

No objections were received prior to the end of 19 July 2024 and the following decision was therefore entered into the record:

In accordance with Section 12.4 of the Board and Board Committee Operating Procedures, on a no-objection basis, the Gavi Alliance Board:

<u>Appointed</u> Nadeem Mahbub of Pakistan as Alternate Board member representing the implementing country constituency in the seat currently held by Nadeem Jan of Pakistan, effective immediately and until 31 December 2026.

2) On 5 August 2024, Board Members were invited to consider **approval of the reappointment of Appeals Tribunal Members.**
