1) On 8 January 2024, Board Members were invited to consider approval of the appointment of an Alternate Board Member and an Audit and Finance Committee Member.

No objections were received prior to the end of 18 January 2024 and the following decision was therefore entered into the record:

In accordance with Section 11.3 of the Board and Board Committee Operating Procedures, on a no-objection basis, the Gavi Alliance Board:

- a) <u>Appointed</u> George Laryea-Adjea as Alternate Board Member representing UNICEF, effective immediately and until his successor is appointed; and
- b) <u>Appointed</u> Onei Uetela (Alternate Board Member) to the Audit and Finance Committee, effective immediately and until 31 December 2025.
