

**SUBJECT: NO-OBJECTION CONSENT DECISIONS**

Since the June 2020 Board meeting, four decisions have been circulated to the Board electronically for approval by no-objection consent in line with Section 11 of the Board and Committee Operating Procedures.

- 1) On 30 July 2020, Board members were invited to consider **approval of the appointment of a Board member and Market-Sensitive Decisions Committee member.**

No objections were received prior to the end of 12 August 2020 and the following decision was therefore entered into the record:

*In accordance with Section 11.3 of the Board and Committee Operating Procedures, on a no-objection basis, the Gavi Alliance Board:*

- a) **Appointed Lia Tadesse** of Ethiopia as Board Member representing the implementing country constituency in the seat currently held by Amir Aman Hagos of Ethiopia, effective immediately and until 31 December 2020; and
- b) **Appointed Lia Tadesse** (Board Member) to the Market-Sensitive Decisions Committee, effective immediately and until 31 December 2020.

d) **Appointed** the following to the Governance Committee
