### Section A: Overview

### 1. Executive summary

- 1.1 On 23 September 2015, the Secretary wrote to Board members informing them that Board and Committee nominations should be submitted by 6 November 2015. This report sets out recommendations for Board and Committee membership in light of the nominations received.
- 1.2 A number of organisations and constituencies have proposed reappointment of their Board and/or Committee members. Where new candidates have been proposed these are highlighted in yellow.
- 1.3 The Governance Committee noted that the **Programme and Policy Committee Charter states that** "Board Members/Alternates and Committee Delegates will be eligible for membership on the Committee with a majority of members being Board Members/Alternates", and that the proposed composition of the Committee as outlined in this paper is 6 Board Members/Alternates and 11 Committee delegates. Governance Committee agreed that this should be considered as part of the Charter review and the Board and Committee self-evaluation which are on the work plan for 2016.
- 1.4 As further background information for the Governace Committee discussions, information on attendance at Board and Committee meetings over the past two years can be found in Annexes 1 and 2 respectively.





# 2. Recommendations

- 2.2 The minutes will note that Board members who are candidates for these positions, or whose organisations or constituencies provided candidates for these positions, did not participate in discussion or voting on these nominations.

## Section B: Content

## 3. Constituency processes for Board nominations

3.1 During its meeting on 18 September 2015 the Board approved the appointment of Ngozi Okonjo-Iweala as an **Unaffiliated Board member** 



effective 1 January 2016 to 31 December 2018 in the seat currently held by Dagfinn Høybråten. The terms of Mr Wayne Berson and Dr Richard Sezibera come to an end on 31 December 2015. Mr Berson is not eligible for reappointment. Dr Sezibera has indicated his willingness to serve a further term on the Board.

- 3.2 In line with normal practice, a recruitment subcommittee of the Governance Committee recently reviewed a role specification and timelines for the selection and appointment process of Unaffiliated Board Members. Based on this specification, the recruitment subcommittee reviewed a list of potential candidates, agreed on a short-list and is finalising interviews, with the aim, primarily, of filling the seat to be vacated by Mr Berson. It is hoped that it will be possible to share the name and biography of the candidate with the Governace Committee in advance of its meeting on 1 December. Should this not be possible the information will be shared during the meeting. The work of the subcommittee will continue to identify candidates for the Unaffiliated Board seats to be vacated during 2016 and 2017.
- 3.3 Nominations from the **developing country governments** were submitted following consultative processes within each of the relevant groups. These processes were coordinated by incumbent Board members, primarily by email, and in some cases, finalised during discussions of constituency representatives at Gavi side-events organised within the margins of relevant WHO Regional Committee meetings. The Governance Committee will note that two nominations were received from the EURO region for the Alternate Board seat for that region. The constituency has been informed that the Governance Committee will consider the nominations and make a recommendation to the Board.
- 3.4 Nominations from **donor country governments** were also submitted following consultative processes within each of the relevant groups. When submitting their nominations the group of countries comprising France/Luxembourg/European Commission/Germany indicated that the European Commission would hold their Board seat for 2017 and that France would then hold the Alternate Board seat.
- 3.5 The Board member representing the **research and technical health institutes** coordinated a consultative process within his constituency. When submitting nominations he indicated that, in order to ensure continuity in representation on the Board, the candidates being nominated as Alternate Board member would be nominated to take the Board seat after a two year period.

#### 11. Gender implications

- 11.1 Board-approved guidelines on the Gavi Board gender balance state that a ration of 60/40 male/female Board Members and Alternate Board members should be established and maintained. For the purposes of this calculation, the Board Members and Alternate Members are assessed as separate groups. The gender balance is deemed to be within the acceptable range if there is no more than 60% of any one gender.
- 11.2 The Board currently has 19 men (68%) and 9 women (32%) with one seat vacant. 10 alternates are men (56%) and 8 are women (44%).
- 11.3 Based on the nominations received and pending Board approval, as of 1 January 2016, the Board would be composed of 16 men (57%) and 12 women (43%). 11 alternates would be men (61%) and 7 would be women (39%).

# 13. Board members

- 13.1 **Sania Nishtar** is President and Founder of Heartfile, an NGO think-tank which is the most powerful heath policy voice and catalyst for health reform in Pakistan. She holds a fellowhip of the Royal College of Physicians and a PhD from Kings College, London. She is widely respect as a global health expert, serves as as advisor to the WHO on various initiatives and is a member of many expert working groups and task foreces of WHO in areas spanning health systems, chronic diseases and public private engagement. She is a faculty member of the World Economic Forum (WEF), and a number of other international commissions and initiatives. She served as Federal Minister of the Governament of Pakistan during the 2013 caretaker government as Minister for Science and Technolocy, Education and Trainings and Information Technology and Telecom. She served as Chair of the Gavi Evalatuio Advisory Committee from 2011 to 2014.
- 13.2 Edna Yolani Batres is Secretary of State at the Bureau of Health, in the government of President Juan Orlando Hernández, of the Republic of Honduras since January 2014. Minister Batres, an experienced physician with a master's degree in public health, has had an outstanding professional trajectory of more than 17 years within the Secretariat of Health, having served as Deputy Secretary of Health for Service Networks; Head of the Unit for Coverage Expansion for the Health Region of Gracias, Lempira; and Chief of the Emergency Services at the Departmental Hospital Juan Manuel Gálvez, among other important positions. Doctor Batres has also served as consultant of the Inter-American Development Bank (IADB) for technical capacity-building within the Unit of Decentralized Management of the Secretariat of Health, to support the expansion and sustainability of health services delivery. During her administration, she has given high priority to the Expanded Program on Immunization (EPI), to maintain the control, elimination and eradication of vaccine preventable diseases and the introduction of new vaccines.
- 13.3 **Raymonde Goudou Coffie**, Minister of Health, Côte d'Ivoire (*Biography pending*)
- 13.4 **Ingrid-Gabriela Hoven** was appointed Director-General of the Department for Global issues – sector policies and programmes of the Federal Ministry for Economic Cooperation and Development (BMZ) in October 2014. She has worked for the BMZ since 1986 in several different positions, most recently as Special Envoy for Climate and Development. From 2010 to 2014, Ms Hoven served as Executive Director to the World Bank Group, representing Germany. After receiving a diploma in Economics and Political Sciences from the Justus-Liebig-University Gießen and the University Paris



IX/Dauphin, Ms Hoven conducted a research study on 'Factors for Success in Non-Traditional Exports from Colombia' during her postgraduate studies at the German Development Institute (GDI). In 1986 Ms Hoven joined the German Federal Ministry for Economic Cooperation and Development (BMZ) as Desk Officer in the field of bilateral cooperation with southern Africa and regional development policy. After four years in this position, she became an Advisor to the Planning Secretariat and the Finance Ministry in Guatemala in the Deutsche Gesellschaft für Technische Zusammenarbeit (GTZ) GmbH. In 1993 she moved to the Department for Economic and Social Policy as Planning Officer. Here she focused on public finance, propoor economic policies and capacity development. In 1995 Ms Hoven returned to the BMZ and held several positions at the BMZ, including as Head of the BMZ Environment Division and as Director-General, responsible for bilateral development policy and cooperation, United Nations development programmes, crisis prevention and peace building, human rights and good governance, and bilateral cooperation with Asia and Latin America. Ms. Hoven is a member of the board of the Global Fund to Fight AIDS, Tuberculosis and Malaria (GFATM) and serves as Co-chair to the Global Facility for Disaster Reduction and Recovery.

- 13.5 Richard Sezibera is Secretary General of the East African Community, the regional intergovernmental organisation of the Republics of Kenya, Uganda, the United Republic of Tanzania, Republic of Rwanda and Republic of Burundi. The Community has the ultimate aim of forming a political federation. The partner countries have formed a customs union, a common market, have signed a protocol on monetary union and cooperate on many areas including infrastructure development. Prior to his appointment, Dr. Sezibera served as Minister of Health of the Republic of Rwanda (October 2008 - April 2011), and as a Gavi Board member representing developing country governments. Dr. Sezibera has served in many capacities in the Rwandan government, including Ambassador to the US, Presidential Special Envoy to the Great Lakes Region, and Senior Advisor to the President of Rwanda, where he worked on peace and security, conflict management and resolution, and regional integration issues. Dr. Sezibera is a Medical Doctor by profession, a father of five and is married to Ms Eustochie Sezibera.
- 13.6 **Angela Santoni** is an immunologist with forty years of experience in biomedical research. She teaches immunology and immunopathology at the School of Medicine of the "Sapienza" University of Rome, where she heads the Department of Molecular Medicine. She is currently the Scientific Director of the "Pasteur Institute Fondazione Cenci Bolognetti" of Rome, a private non-profit foundation specialised in biomedical research. For several years she was a researcher at the Laboratory of Experimental Chemotherapy and Immunodiagnosis, and at the Biological Response Modifiers Program, of NCI-NIH, Bethesda. She is a member of several national and international committees, with specific expertise in Molecular Biology. She is a member of several editorial boards of scientific publications in Europe and the US, an author in highly qualified international



journals, and a guest speaker at several national and international scientific congresses.

13.7 Samba O. Sow MD, MSc. is Director General of the Center for Vaccine Development (CVD) in Mali and Professor of Medicine at the University of Maryland School of Medicine. A physician and epidemiologist, he coordinates epidemiological studies and clinical trials on vaccine preventable diseases that inform governmental policy. His research spans diverse vaccines and vaccine-preventable diseases. He serves on the Scientific Advisory Panel for Mali's ICC, WHO's Global Training Network, the Pneumococcal Awareness Council of Experts, and on WHO-SAGE meningitis working group. Dr Sow's received the 2000 "Paul Laviron" Prize in Tropical Medicine from the University of Marseille and was Commemorative Fund Lecturer of the American Society of Tropical Medicine & Hygiene in 2006.

## 14. Alternate Board members

14.1 Sergey Khchatryan, former Director of World Bank supported Health Project Implementation Unit of Republic of Armenia, was appointed as the Deputy Minister of health on November 2010. As a Deputy Minister of health, Dr S Khchatrvan is responsible for coordination of Public Health (including immunization), Mother and Child health, International relations, Partnerships. Dr Khachatryan is an accomplished public health officer in the field of immunization and vaccine preventable diseases who played a critical role in developing the national immunization policies and strategies. With a focus on advocacy and resource mobilization, he created partnerships and bridges cross-cutting development themes to grow and strengthen the movement of controlling and eliminating VPDs in Armenia (there are no polio, diphtheria, mumps, measles, and rubella cases). Under his leadership and coordination Armenia has expanded its National Immunization Programme through successfully and smoothly introduction of new vaccines (rotavirus in 2012 and pneumococcal in 2014). He manages the Immunization Programme operations and provides key support to the National Immunization Programme manager and immunization team in advocacy and resource mobilization activities resulting Immunization budget increase 3 times in 2015. To sustain high routine immunization coverage rates in the country, Dr. Khachatryan personally manages supportive supervisions and discussions on findings, planning, implementation, monitoring and evaluation of immunization activities, coordination of ICC (ICC member since 2010), NITAG meetings. He is well known on each district performance. Dr Khachatryan brings extensive experience collaborating with international and multilateral agencies (GAVI, WHO, UNICEF, USAID), private sector, non-governmental organizations to expand infection disease control and prevention, and outbreak response measures around the whole country. Due to his active involvement and advocacy Armenian Government signed the Partnership Framework Agreement with Gavi .



- 14.2 Paata Imnadze holds a PhD Degree from the Tbilisi Medical State University in 1983 and Degree of Medical Doctor from the same university. Dr Imnadze is the Scientific Director at the National Center for Disease Control and Public Health (NCDC), Georgia. Prior to his current position (1992-2010), he was Director General of the NCDC. Addition to this, he continues to serve as the head of the Department of Public Health at the Tbilisi State University, and was formerly Associate Professor of the Department of Microbiology and Immunology at the Tbilisi State Medical University. Besides expertise in immunization, his professional experience includes epidemiology of communicable diseases, biosafety, infection control, microbiology, molecular epidemiology, emergency preparedness and response. Dr Imnadze is a member of the Interagency Coordination Committee (ICC) since 2000, and a member of the National Immunization Technical Advisory Group (NITAG) from 2014 up to present. He was a member of the WHO European Technical Advisory Group of Experts on Immunization for 9 years (2002-2011). In 2002 he was awarded with the lapel pin to commemorate Polio-Free Europe. Dr Imnadze is an author of several peer-reviewed articles in immunization and vaccine-preventable diseases epidemiology.
- 14.3 **Felix Kabange**, Minister of Health, Democratic Republic of the Congo (*Biography pending*)
- 14.4 **Jan Paehler** leads the team working on Global Health Initiatives in the European Commission's Directorate General for Development Cooperation. He is an alternate board member at the Global Fund since 2011 and served on board committees on strategic and financial oversight. He also chaired two nomination committees for leadership appointments at the Global Fund. Jan was a GAVI board member in 2014. Jan is a medical doctor with a PhD in cardiology and an MSc in Health Systems Management. Jan spent five years in Ghana. First in clinical service for the Ghana Health Service in Accra, then overseeing government grants as USAID's Child Health and Infectious Disease Advisor. In this capacity Jan also served on the local ICC. Before moving to the European Commission, Jan worked for the Advisory Council on Developments in the German Health Care System, the major government think tank on health systems advising the German Minister of Health.
- 14.5 **Bradford D. Gessner,** is the Scientific Director of Agence de Medicine Preventive in Paris, France and Professor of Pediatrics at the University of Washington. Dr. Gessner trained as a pediatrician at the University of Colorado, completed a preventive medicine residency at the University of Washington, and completed Epidemic Intelligence Service training with the US CDC. The author of over 170 scientific manuscripts, he coordinates, oversees, and implements the scientific aspect of AMP's work on field vaccinology, including large-scale clinical trials, surveillance, vaccine impact, coverage improvement, vaccine safety systems, laboratory improvements, economics, anthropology, communication, and training. Dr. Gessner has conducted worked in 18 Gavi-eligible African countries, and the key Asian countries of Bangladesh, India, Indonesia, Pakistan, and



Vietnam. Current committee memberships for Gavi include the Strategic Goal 2 Working Group and as part of the advisory committee for the Board's Science and Research constituency. For WHO, he currently serves on IVIR-AC and IPAC, SAGE working groups on non-specific vaccine effects and maternal and neonatal tetanus elimination, a GACVS working group on RTS,S vaccine safety, the Invasive Bacterial Vaccine Preventable Disease ITAG, and as lead for a technical working group on perinatal influenza impact.

14.6 **Javier Hernández Peña** has been the Deputy Director General for Development Policies in the General Secretariat for International Development Cooperation at the Spanish Ministry of Foreign Affairs and Cooperation since 2012. Before this position, he was the Deputy Director General for Institutional Affairs in the Secretariat of State for the European Union. He has also had several diplomatic appointments worldwide and was part of the negotiation of the Cotonou Agreement. Javier Hernández Peña has a degree in Law, specialised in European Community Law.

# 15. Committee delegates

## Audit and Finance Committee

15.1 **Heidi Malene Nipe** joined the Norwegian Ministry of Foreign Affairs in January 2015. She serves as Senior Advisor in Section of Grant Management, especially towards the global health sector. Her focus consists within financial and project management including internal controls, particularly relating to multilateral organisations. Before joining the Ministry, she worked eight years with audit in PricewaterhouseCoopers (including one year in Singapore), first as associate and later as manager. Heidi holds a Master of Science in Economics and Administration, a Master in Professional Accountancy from BI Norwegian Business School and entitles as a State Authorized Public Accountant.

## Programme and Policy Committee

- 15.2 Lindsey Dietschi is the Corporate Affairs Lead for Pfizer Vaccines. In this role, she works across Public Affairs, Policy, Communications, Corporate Social Responsibilityand Media Relations to support access to vaccines for people of all ages. In addition, she is a member of the International Federation of Pharmaceutical Manufacturers and Association (IFPMA) Vaccines Committee. Before her positions in vaccines, Lindsey worked to advance smoking cessation policies, including smoke-free air laws. She earned a Bachelor of Arts in Spanish from Michigan State University and a Master of Business Administration (MBA) in Marketing and Management from the Leonard N. Stern School of Business at New YorkUniversity (NYU). She is currently an Adjunct Professor in the Management Communications Department at NYU and has served as a guest speaker on Organizational Communications at Unilever.
- 15.3 **Robin Nandy** is, since December 2011, the Chief of Child Survival & Development in the UNICEF Indonesia country office. Prior to this, Robin



was the Team Lead for the Global Polio Eradication Initiative at UNICEF Headquarters during 2010-2011 and the Team Lead for Health in Emergencies during 2006 -2011. He is a medical epidemiologist and public health physician with an extensive background international public health, particularly in the areas of immunisation and in humanitarian health response. Previous to UNICEF, he has worked as a medical epidemiologist at the Global Immunisation Division of the Centers for Disease Control & Prevention (CDC) in Atlanta (2002 -2006). He has also worked at both the country and headquarters level with the International Rescue Committee (IRC) during 1998-2002 and for the Indian government in the Republic of Maldives. As a Medical Officer, he worked four years in various hospitals in New Delhi, India (1990-1994). Robin obtained his medical degree from Mysore University, India (1990) followed by an MPH at the Nuffield Institute for Health, Leeds, UK (1996). He completed the Epidemic Intelligence Service (EIS) fellowship at the CDC (2002-2004).

- 15.4 **Shanta Bahadur Shrestha** was born in Palpa District in western Nepal and he joined the Government of Nepal as a section officer 35 years ago. With a Masters in Public Adminstration, he served in a number of ministries over this period. He was Joint Secretary at the Ministry of Finance in 2012 and was then assigned to the Ministry of Federal Affairs and Local Development where he served for 2 years and played significant role in the endorsement of a collaborative framework of health and local development. Since 2014 he is Secretary of the Ministry of Health and Population and actively involved in the campaign of full immunisation declaration at various village development committees, municipalities and districts across the country. From his experience and engagement at the Ministries of Finance and Local Development he has a keen interest in being involved in ensuring the sustainability of funding for immunisation.
- 15.5 **Dure Samin Akram** is a renowned professor of Pediatrics in Pakistan. Dr DS Akram has also remained Chairperson of the Department of Pediatrics at Dow University of Health Sciences, Karachi for 10 years, and currently is the Honorary Chairperson of the "Health Education and Literacy Program" CSO. She was elected as President of the Pakistan Pediatric Association and served at that post between 2002-2004. In addition to obtaining Certification in the American Board of Pediatrics, she also did an MPH in Epidemiology of Infectious Diseases with a special interest in Vector borne infections. Dr DS Akram has authored over 65 scientific papers published in National and International peer reviewed journals. These articles include original research on Poliomyelitis and Dengue infections in Pakistan. She is a practicing pediatrician and an Honorary Faculty member in the Department of Pediatrics at Aga Khan University in Karachi, Pakistan.

15.6 **Jeanine Condo** is Associate Professor of Public Health at the School of Public Health and Acting Principal of the College of Medicine and Health Sciences in Kigali, Rwanda. She has served the school of public health since 2002 where she became the deputy dean in charge of research and



projects from 2011 to 2013 and acting dean from October 2013 to January 2015. A physician and expert in the evaluation of health programmes, she leads a wide-reaching teaching and research programme. She serves on the Technical Evaluation Reference Group of the Global Fund to Fight AIDS, Tuberculosis and Malaria, and is a Commissioner Member of the International Initiative for Impact Evaluation (3ie). Her areas of interest and expertise include evaluation design and methods, maternal and child health and more specifically nutrition and health system strengthening.
