

SUBJECT: GOVERNANCE COMMITTEE CHAIR REPORT

Section A: Introduction

- This report provides the Board with an overview of the activities of the Governance Committee (GC) since the Board last met in November 2018.
- The GC met by teleconference on 12 February 2019 and had an in-person meeting in Ottawa, Canada, on 26 March 2019.
- In addition to some routine business such as Board and Committee nominations and the recruitment of Unaffiliated Board members, Committee discussions at both meetings focussed primarily on work in relation to the 2019 Board Effectiveness Review and recruitment of a new Chair for the Evaluation Advisory Committee.
- A number of Board and Committee nominations submitted to both meetings have already been circulated to the Board for no objection consent.
- The GC will meet on 24 June 2019, preceding the Board meeting, and it is expected that further recommendations will be put forward to the Board on the consent agenda at its June meeting.
