

ALLOCATION ROUND 5: Pfizer-BioNTech Vaccine

15 July 2021

Introduction

Based on current knowledge of COVID-19 vaccine supply availability, this fifth round of COVAX Facility allocations provides information on the provision of 72,190,170 doses of the Pfizer-BioNTech vaccine, allocated to 99 participants,¹ covering the period July – September 2021.

These doses are made available to the COVAX Facility both through the advance purchase agreement (APA) between Gavi and Pfizer, as well as a procurement of additional Pfizer doses facilitated by the United States.

Facility participants not included in this round (and therefore not listed in the table below) either: elected to skip this particular allocation round, opted out of receiving the Pfizer-BioNTech vaccine, had already reached 20% total population coverage (or requested coverage level if less than 20%) through previous allocations (including donations), or were a self-financing participant (optional purchaser) whose pro-rata share of the Pfizer-BioNTech vaccine has already been fulfilled through previous allocations.

Overview of the Process

This fifth round of allocations took place as per the Fair allocation mechanism for COVID-19 vaccines through the COVAX Facility, which was developed by WHO in consultation with its Member States. This allocation framework for fair and equitable access to COVID-19 health products sets forth the criteria and approach to allocation of vaccines through the COVAX Facility.

The operationalization of the Framework, in accordance with the principles and provisions set forth in the document, is performed by the Joint Allocation Taskforce (JAT), composed of staff from Gavi, the Vaccine Alliance and WHO, and the Independent Allocation of Vaccines Group (IAVG). The main purpose of the IAVG is to make validation assessments of proposals for Vaccine Allocation Decisions (“VAD proposals”), which outline the volumes of vaccines that should be allocated to each country/economy participating under COVAX within a given time frame. The IAVG will consider VAD proposals prepared and submitted by the JAT.

¹ There are two additional participants for a total of 2,949,570 doses, where technical and legal issues will need to be reviewed.

COVAX

The population coverage reached in the COVAX Participants that received the early Pfizer-BioNTech doses was factored into this present allocation round, as were previous allocations under the COVAX Facility, and the dose donations executed so far. Furthermore, included in this round is a volume of 59,999,940 Pfizer doses made available to COVAX for delivery in Q3 2021 through procurement facilitated by the US government. The round took into account that these doses are earmarked specifically to the entire group of AMC participants, as well as to six self financing participants who are members of the African Union.

A vaccine allocation decision (VAD) proposal was developed by the JAT and shared with the IAVG for their review on 06 July 2021. Subsequently, the IAVG decision meeting for the round was held on 08 July 2021. The deliberations resulted in consensus on the vaccine allocation decision proposal, with no divergent views recorded.

The allocation was then validated by the WHO Deputy Director-General, and the decision was communicated to the Office of the COVAX Facility, administered by Gavi.
