Gavi's approach to supporting middle-income countries facing challenges related to fragility, emergencies, and displaced populations

A key tool for sustaining routine immunisation programmes

Countries¹ affected by fragility, insecurity, conflict, and emergencies face unique challenges in sustaining routine immunisation service provision and uptake. In these contexts, large parts of the population, including displaced communities, are at an increased risk of being left behind. As immunity gaps widen, there are also significant threats to the progress made in eliminating and eradicating vaccinepreventable diseases. In recognition of this, in June 2022 the Gavi Board approved dedicated support to help sustain routine immunisation programmes in middle-income countries facing challenges related to fragility, emergencies, and displaced populations².

Country eligibility

In order to be considered for dedicated fragility support, countries must be eligible under the MICs Approach. Table 1 presents the list of eligible countries as of July 2022.

Conditions for support

Countries eligible under the MICs Approach must meet three conditions to be considered for dedicated fragility support to help sustain their routine immunisation programmes. These conditions are:

- 1 The country must fall within the classification for settings of chronic fragility, acute emergencies and/or hosting displaced populations as per Gavi's Fragility, Emergencies and Displaced Populations Policy³;
- 2 There must be an evidence-based demonstration of a time-limited need against which Gavi is best placed to respond in line with the Alliance's comparative advantages; and
- 3 Gavi's support must remain time-limited and the country must give a clear commitment to sustain funding for immunisation following the end of Gavi support, thereby assuring a clear exit strategy and avoiding the creation of dependencies in line with Gavi's development model.

Dedicated fragility support through the MICs Approach

Support for countries facing challenges related to fragility, emergencies, and displaced populations is time-limited and determined on a case-by-case basis. The details of support are defined in collaboration with in-country partners to ensure that Gavi's efforts are complementary to those of others.

Dedicated support may include:

- A portion of vaccine financing for existing routine vaccines;
- Technical assistance; and/or
- Access to Gavi prices⁴.

Gavi is continuously monitoring the status of countries eligible under the MICs Approach facing situations of fragility, emergencies, or displaced populations. Gavi welcomes discussions with countries or partners interested in exploring relevant challenges in more depth.
